# How to use the 2025 - 2026 CEU Planner for *Louisiana Social Workers*

- This Planner outlines each month of the noted CEU reporting year.
- For each month, list keywords about each CEU you took or *want* to take (*plan ahead!*). Include a short date, the # and type of CEU Hours. Keywords help you search records for certificates, registrations, etc.
- In each month's box, add up and identify hours earned that month; this will help you add up the total for the year.
  - G = General, E = Ethics, C = Clinical (Note if C-BACS)
  - Note whether CEU Hours were LIVE & SYNCHRONOUS (or not)
  - Effective October 20, 2025, new rules were promulgated:
    - *"Synchronous interactive webinars are considered in-person continuing education."* (per LABSWE email 10/20/25)
    - *"All licensed social workers may carry over up to 10 hours of continuing education collected during the period 09/01/25 to 08/31/26 to the collection period 09/01/26 to 08/31/27 with the exception of ethics hours and clinical supervision hours required for BACS."* (per LABSWE email 10/20/25)
    - *Please call LABSWE or visit the LABSWE website for more info.*
- Use the Overall CEU Tracker to stay on track. Note all of your hours. Plan ahead to avoid rushing to get your CEUs in August each year!
- *Did you know Louisiana is a Self-Assessing State? CEUs do not need to be pre-approved - **you** can actually approve a CEU with the rubric provided by LABSWE. More Info @ Chapter 13 §305 of the Rules, Standards + Procedures. The LABSWE rubric is also available on our site as a free download!*



# 2025 - 2026 CEU Planner for the *Louisiana RSW*

- Required: 20 CEU hours Annually, prior to renewal. As of October 20, 2025, it is our understanding the rules have changed for in-person requirements: synchronous, interactive (webinars or in-person) = LIVE.
- Of the 20, 10 hours must be LIVE & *SYNCHRONOUS*.
- Also still required: 3 Ethics CEU Hours *every 2 years*.
